I. Welcome and Introductions: *Craig Balben, President.*

The meeting was brought to order at 8:10 AM.

II. Approval of Meeting Minutes: *August 10, 2017:*

Meeting minutes were accepted into the record as presented.

III. Treasurer's Report: *Craig Balben on behalf of Aaron Byzak, Treasurer.*

- General account: **\$890.85**

IV. Presentation: *Marian Novak, Responsible Hospitality Coalition (RHC):*

RHC promotes responsible principles and practices in the sale and service of alcohol beverages and collaborates between other prevention groups, law enforcement, government, hospitality, and business improvement districts to promote a safe community. Marian Novak, Project Director, shared a PowerPoint overview of the program activities including:

- RBS (Responsible Beverage Service) Trainings/ABC LEAD (Licensee Education on Alcohol and Drugs): During FY 2015/16, 2,362 persons were trained in 56 LEAD trainings countywide. At these trainings, 99% of post survey respondents answered "yes" that *they would recommend the training to others who sell or serve alcohol*. 12 cities, including Oceanside and Vista, have mandatory RBS ordinances.
- Place of Last Drink Data Survey (POLDD): POLDD surveys are collected monthly at San Diego County DUI Programs; the survey helps to identify problem businesses.
- Business Risk Assessments: RHC works with problem bars to improve their RBS service.
- Special Event Volunteer Trainings: During FY 2015/16, a total of 4,183 volunteers were trained in 134 Special Event Trainings in the county.
- Designated Driver Programs – RADD®: Local bars and restaurants promote and support the RADD message by giving designated drivers special "RADD Rewards" like free sodas and discounted food.

V. Discussion Items/Program Updates:

Marijuana Policy/Regulations:

Carlsbad – City Council voted on 9/12 to introduce an ordinance (Option 1) to amend city code to ban commercial marijuana activities.

Oceanside – Ad Hoc Committee final public hearing will be held on 9/28; will report back to the full city council sometime in November.

Vista – No change for now; council will readdress marijuana regulations at their meeting on 9/26.

K1 Speed in Carlsbad:

August 22: Carlsbad City Council denied (Vote 4-1) Planning Commission’s approval for K1 Speed’s liquor license application.

Carlsbad Distillery:

July 25: Carlsbad City Council voted 2-2 not to allow distilleries downtown (barrio district), but unanimously supported allowing restaurants.

Regal Theater Downtown Oceanside: In response to the Regal Theater’s alcohol license application, NCPC Board is sending a letter to OPD outlining NCPC’s concerns with the application and commending OPD for filing a protest.

Underage Drinking Forum-STOP Grant Activity:

Underage Drinking Forum was held September 5 at the Oceanside Civic Center; 60+ high school and college students attended and were treated to “Taco Tuesday” dinner before the forum started. Forum guest panelists included youth, law enforcement, MADD rep, and Jacob Wallis (father of Baby Izaiah).

VI. Announcements:

Debal Acquaro, San Diego County-Senior Public Health Nurse: Shared important county outreach efforts and vaccination information regarding the recent HEP A outbreak. The board suggested presenting a more in depth report on the HEP A health crisis at an upcoming meeting. Debal also provided the county link below:
