<u>Marijuana Dispensaries</u> – <u>June 25 Oceanside Council Meeting:</u> Aaron reported that the city council unanimously voted to deny a request from a medical marijuana dispensary to change zoning rules to allow pot shops in the city. He thanked everyone who attended in support of NCPC's opposition to the amendment.

<u>Meeting Location Rotation:</u> August 14<sup>th</sup> meetings will be held at the Carlsbad Safety Center, and October 9<sup>th</sup> meetings will be held at the Vista Community Clinic-Women's Center. Debbie will send repeated reminders as the date gets closer so everyone gets the notice prior to the meeting dates.

## NCPC By-Laws-Review:

Members were sent an electronic copy of the revised by-laws for review. Dale Walton motioned to approve as revised; seconded by Margie O'Hern, and passed unanimously. Debbie will post revised copy on the NCPC website and forward a copy to the Secretary of State with annual tax filing.

## Dr. Boyle 30 Min. Video:

Aaron is continuing to work with Dr. Boyle to develop/produce a 30 minute abbreviated version of her presentation: "Impacts of Marijuana Use on the Developing Adolescent Brain." The video will be recorded/produced by NCPC and made available for distribution; looking at costs of about \$500. NCPC is looking at production options with KOCT, UCTV, and John Paul the Great University. Ray T. mentioned that he would be at JPG University later in the day and would try to get more information on their ability/interest in working on this type of project; he will get back to John B. with any additional input.
