I. Welcome and Introductions – Aaron Byzak, President:

II. Approval Meeting Minutes – December 13, 2012:

Meeting minutes were approved as presented.

III. Treasurer's Report – Margie O'Hern:

Margie O'Hern was absent; Debbie Obregon reported the following account balances: General \$614.88; 420 Remix \$1595.53; Youth Coalition \$1342.48; Eastside Neighborhood Assoc. \$58.06.

IV. Presentation: Strategic Planning – Aaron Byzak.

Aaron shared a PowerPoint presentation outlining the three main focus areas identified at the board retreat held this past October. The focus areas identified include: Research, Action, and Sustainability. Committees were developed to define goals and objectives for each focus area and a chair (or co-chair) was assigned to each committee:

Aaron briefly discussed each committee's goals and objectives as outlined and noted that the board will continue to review and formulate the strategic plan through February with a final draft prepared and officially presented at the 20th anniversary celebration in March.

Service to Science Award:

NCPC/VCC received the Service to Science Initiative subcontract award of \$30,000 to support the implementation of our evaluation capacity-building efforts (focus on marijuana initiative). The time period for the one-year award is approximately January 2013 through December 2013. Erica reported that a contract agreement with CSUSM should be completed this week.

Carlsbad Activity Grant:

NCPC has applied for a Carlsbad Activity Grant to develop and host a full-day PSA training/workshop in March for middle and high school students in Carlsbad. The focus will address substance abuse prevention themes, but will also include training that could apply to any discipline. Grant funds (\$3,900.00) would be used to cover consultant fees, venue, refreshments, and prizes.

Anti 4/20 Event:

April 20th falls on a Saturday this year, making Boomers! not an option for our annual anti 4/20 event. NCPC is looking at developing a PSA contest open to middle and high school students to educate peers on marijuana use. Suggested categories include: *Marijuana's impact on physical and emotional health* or *Marijuana's impact on achieving goals*. Contest will be launched on-line by Feb. 1 with opportunities for both group and individual entries. Winning entries will be debuted at a "RED CARPET" event on **April 20**, and will be submitted to the Academy of Arts and Sciences for consideration/possible Emmy nomination.
