#### V. Program Updates:

# Carlsbad Activity Grant - Youth PSA Training November 16:

NCPC was awarded a Carlsbad Activity Grant for \$3900 to host a PSA youth training (ATOD prevention focus) for Carlsbad middle and high school students. Trainers, Aaron Byzak and Erica Holloway (NCPC Media Specialist), will present the training on Saturday, November 16, 10am-3pm, at the Carlsbad Boys & Girls Club, 2730 Bressi Ranch Way. Please contact John Byrom for additional information or to RSVP interested youth.

#### NCTD Coaster Alcohol Policy:

Erica reported that the North County Transit District pulled its' proposal to prohibit the consumption of alcohol on Coaster trains. NCTD said it withdrew the proposal after receiving "robust public feedback." The agency has scheduled a public hearing on the topic for November 21; program staff will attend on behalf of NCPC and present a letter stating NCPC's position and support for the proposed "no alcohol" policy.

## Oceanside Walmart Neighborhood Market alcohol license application:

Members discussed the City of Oceanside's approval of alcohol license application for the Walmart Neighborhood Market at 1046 Mission Avenue (old Office Depot location), directly across from Oceanside High School (500 feet). NCPC is very concerned with the close proximity to the high school and the negative impacts of selling alcohol in an already over-concentrated alcohol outlet and high crime area.

Erica Leary shared a PowerPoint presentation outlining the timeline to this point of Walmart's alcohol license application process. Unfortunately NCPC was not aware of the application as it moved through the steps ("slipping under the radar"), and the period of public protest has passed. Erica noted the following opportunities to further address this issue:

- Councilmember Sanchez has requested item on November 20 City Council agenda to classify alcohol retail sales near sensitive uses as 'regulated uses' that would require a CUP;
- > OPD has indicated that the department would support a comprehensive CUP process for all alcohol license applications;
- > The Alcoholic Beverage Control (ABC) is waiting for additional input from OPD before issuing the actual license type;
- > Store management is meeting with OPD and ABC on November 14 to discuss resident concerns and possible conditions;
- > Public pressure on Walmart NCPC youth coalition members have suggested a petition and/or letter writing campaign;
- > NCPC members suggested a community meeting with public input from area residents.

VII. Adjourn: The meeting was adjourned at 9:20a.m. Next meeting will be held Thursday, December 12, 2013, 8-9am.
