Vista: Vista City Council agreed to draft a counter initiative to compete with a citizen's initiative on the November 2018 ballot. City's final draft should be ready for review before June.

Oceanside: Last March, council members approved developing regulations for the manufacture, cultivation, and distribution of medical marijuana, but rejected dispensaries. The proposed ordinance was sent back to staff for review of licensing, permits and fee structures; OPD also given additional time to analyze potential impacts. A June deadline has been set for staff and OPD to return with their recommendations.
