IV. Discussion Items and Program Updates:

Local Marijuana Policy – John Byrom:

Vista City Council members met on June 12 and approved two initiatives on the November 2018 ballot to counter the pro-marijuana initiative. The first measure is to allow three delivery services and no dispensaries; the second is a tax ballot measure to set taxes on marijuana dispensaries should any current or future marijuana measures pass. The city's tax measure would also tax illegal dispensaries. The Citizens Initiative severely limits City oversight, including reducing violations to infractions, and permitting dispensaries in multiple zones with no special use permit required.

An Oceanside community group filed an initiative with the City of Oceanside that would replace, if passed, the medical marijuana ordinance approved by the City back in April. This group needs to collect 10,000 Oceanside resident signatures to place the measure on the 2020 ballot. Oceanside Council members will host a workshop on June 20 to address OPD Chief McCoy's report to council regarding the potential impacts of marijuana dispensaries; council will also address a change in zoning for the 1000 foot distance requirement between grow sites. NCPC members are invited to attend.
