IV. Discussion Items and Program Updates:

Local Marijuana Policy – Erica Leary:

Vista:

Last September the citizen's marijuana initiative qualified for the November 2018 ballot. This initiative severely limits city oversight, including reducing violations to infractions, and permitting dispensaries in multiple zones with no special use permit required. In response, city council members met on June 12 and approved two initiatives to counter the pro-marijuana initiative. The first measure allows only three delivery services, and NO storefronts, cultivation or manufacturing; council members did approve testing. The second measure is a tax ballot to set taxes on marijuana dispensaries should any current or future marijuana measures pass. The city's tax measure would also tax illegal dispensaries.

Board members discussed getting signatures from key individuals on a statement favoring of the city's initiatives.

Oceanside:

On June 20, city council members hosted a workshop and heard OPD Chief McCoy's report regarding potential impacts of marijuana dispensaries. The council approved 2 distribution centers, 3 delivery services, but no storefronts. The city is now in the process of designing regulations.

Announcements:

Aaron Byzak provided insight about Tri-City Medical Center's recent decision to suspend operations of their behavioral health unit (BHU) and crisis stabilization unit (CSU). The decision was made because of three reasons: changes to federal regulations related to the environment of care, a national shortage of psychiatrists that has impacted staffing, and low reimbursement that makes the service financially unsustainable. Tri-City Medical Center is, however, expanding its outpatient behavioral health services and pursuing significant legislative reform to address these issues.

Aaron also reported that in an effort to support non-profit organizations that are aligned with the Hospital Association's findings in their Community Health Needs Assessment (CHNA), including addressing behavioral health issues such as alcohol and drug abuse, Tri-City Medical Center is entering into a sponsorship of NCPC's award winning programs, activities, and events at the level of \$5,000 for the FY18/19 year.
