## IV. Presentation – STOP ACT Grant/Young Adult Underage Drinking Survey: Summary & Findings.

Focus of STOP Act grant is to work with young adults to reduce underage drinking and decrease use of alcohol by youth ages 12-17 by decreasing access. Erica Leary, NCPC Program Manager, and Melissa Campbell, NCPC Program Prevention Specialist, shared STOP survey/assessment data collected in 2017/2018 at various locations including Mira Costa and Palomar Colleges, Oceanside's Sunset Market, and VCC's Vale Terrace site. # V. Marijuana Policy – Input from members on what topics/main points they would like hear about from Kevin Sabet at the 25 Year Anniversary Breakfast: Erica Leary.

Lt. Ignacio Lopez, OPD:

OPD is offering a Standardized Field Sobriety Testing Class (comprehensive impaired driver (DUI) detection course); currently 15 students are enrolled. Also noted that ARIDE (Advanced Roadside Impaired Driving Enforcement) classes are also offered by the CHP. The ARIDE program was developed to bridge the gap between SFST and Drug Evaluation and Classification programs by providing law enforcement officers with general knowledge related to drug impairment.
