The mission of the North Coastal : Alcohol: **Prevention Coalition (NCPC) is** to reduce the harm of alcohol. tobacco, marijuana and other drugs in the cities of Carlsbad, Oceanside and Vista through community action, education, support and collaboration.

NCPC is a non-profit organization that began in 1993 and works with partners in education, law enforcement, social services, governmental agencies, youth, and the private sector.

Social Host Ordinances:

NCPC supports and advocates for enforcement of 'social host ordinances' (SHO) to prevent underage drinking at house parties. SHOs hold party hosts responsible for making sure guests under 21 don't have access to alcohol. Local retailers help support the effort by participating in 'Sticker Shock' campaigns.

RBSS Training:

NCPC supports mandatory Responsible Beverage Sales and Service (RBSS) ordinances to prevent

alcohol related problems. The program provides practical information on serving alcoholic beverages responsibly, with an emphasis on preventing sales to minors and to obviously intoxicated persons. In North San Diego County, RBSS training is required in Oceanside, Encinitas, San Marcos, Solana Beach and Vista; and entertainment businesses in Carlsbad.

Marijuana:

NCPC collaborates with Smart Approaches to Marijuana (SAM) learnaboutsam.org to educate our communities about the harmful effects of youth marijuana use. NCPC advocates against the commercial sale of marijuana. As youth perceive marijuana to be less harmful, and there is greater access to marijuana, their use rates are likely to continue to increase.

Other Drugs:

Every day in the U.S. about 2,500 teens use a prescription drug to get high for the first time. Safely disposing of expired or unused prescriptions is one way to prevent abuse. Drop boxes are located at the Carlsbad Safety Center, Oceanside Operations Center and Sheriff Department Stations.





Tobacco and Electronic Vaping Devices:

NCPC supports tobacco control efforts to reduce the availability of tobacco to minors, including the adoption of local tobacco retail licensing (TRL) ordinances. NCPC also supports reducing exposure to second-hand smoke, such as smoke-free dining patios and smoke free multi-unit housing. New technologies, such as Juul electronic cigarettes, pose increasing challenges for parents and others to prevent youth use.

The North Coastal Prevention Coalition meets monthly and welcomes community participation:
