Measure Z Flver:

However, the individual who offered to pay for printing the flyers did not get back to Erica (printing cost approx. \$240). Erica asked the board to consider covering the print cost and noted that NCPC funds approved in September to pay for the CADCA membership renewal (\$200) were not used due to availability of other program funding.

A quorum was not in attendance; Erica requested an email poll for approval for NCPC to cover the printing cost for Measure Z flyers. The five board members present agreed, and subsequent to the meeting, email "yes" votes were received from Ray Pearson, Marie Smith, and Maria Yanez.
