## I. Welcome and Introductions: Craig Balben, President.

The meeting was convened at 8:05 a.m. Craig Balben was absent; meeting was facilitated by Ray Thomson.

John Byrom noted that Marie Smith (adjutant of the North San Diego Young Marines) was not present, but he wanted to recognize her and congratulate the North San Diego Young Marines of Vista on being named "2019 National Unit of the year."

### IV. Presentation/Discussion:

Erica Leary, NCPC Program Manager, reported that NCPC is concerned that Vista City Council members are considering to remove the current ban on marijuana deliveries and permitting the 11 dispensaries approved under Vista's Measure Z to also deliver. She shared an article from the <u>Coast News</u> summarizing the council meeting on June 25th and the council's directive to staff to bring back an ordinance allowing for medicinal marijuana deliveries. In addition, the council is discussing approval of other marijuana businesses such as manufacturing, distribution and testing facilities. This will most likely be re-addressed at the Aug. 27<sup>th</sup> council meeting.

Erica shared a PPT presentation including updates on the commercialization of marijuana in North County (billboards along Hwy 78 corridor publicizing marijuana delivery); included an undercover news story from NBC4 in Los Angeles highlighting difficulties with marijuana deliveries in the LA area; and discussed with members strategies to inform the public and prevent youth use.

Erica explained that NCPC is concerned with preventing youth access to marijuana and is doubtful that adequate systems are available to properly regulate deliveries. In an effort to keep the public informed about local marijuana policy issues in North County, an informational flyer was developed along with a survey to gather community input regarding this issue. The flyer and survey were passed around the group and members offered suggestions on flyer/survey distribution for best resident exposure. Some suggestions included reaching out to apartment complex managers, VCC's Mobile Dental Unit, library displays, and back to school nights.
