Lisa also reported: City of Oceanside is moving forward with review of Tobacco Retail Licensing Ordinance; a draft ordinance will be discussed at the Police and Fire Commission meeting on April 16; Escondido City Council will review/consider strengthening city-wide anti-smoking policies at their next meeting

Erica Leary - 420 REMIX: Erica explained NCPC's new 420 Remix PSA Counter Ad Contest information and noted that the PSA flyer was posted on the NCPC website (link below). NCPC is asking participating youth to create a photo, audio or video message designed to prevent teens from using marijuana.
