**V. Presentation: Steve Wolfe, Facilities Manager-Camp Pendleton and Founder, The Sun Never Sets.**

Steve Wolfe, founder of the Sun Never Sets organization, and daughter Lexie (Junior at Rancho Buena Vista High School), shared a PowerPoint presentation and website outlining the organization’s mission and message. The organization’s mission is “to foster a community for, raise awareness of and destigmatize substance misuse, specifically opioid misuse, in order to combat this epidemic and its impacts on lives...” Mr. Wolfe lost his son Riley to opioid addiction in 2017. Riley was prescribed opioids by his medical doctors for pain following an athletic injury.
