- IV. <u>Program Updates County Contract focus areas for 6 month extension Erica Leary, NCPC Program Manager:</u> Erica shared a quick update outlining the program focus areas for the county contract six month extension (July- Dec 2020). Proposed priorities approved by the county include:
  - 1. Marijuana delivery compliance
  - 2. Vista Smoke-free dining/outdoor spaces
  - 3. Social host awareness (redesign Sticker Shock Campaign in the age of COVID); Aaron suggested contacting COSTCO corporate offices to support this area with stickers on beer multi-packs and/or pizza boxes.
  - 4. Oceanside marijuana policy (Youth group is interested in banning vaping products in Oceanside).
  - 5. San Dieguito Alliance increase public perception of marijuana harms in response to local initiatives.

# V. Group Discussion – Planning for August State Assembly (District 76) Candidate Forum – Aaron Byzak, President: Candidate Tasha Boerner Horvath has declined invitation to attend; Melanie Burkholder has accepted; media outlets will also be

invited. Zoom format will be used; audience members will be auto-muted when joining the meeting; Pre-set questions from NCPC board will be sent to the candidates in advance; following NCPC questions, attendees will be invited to ask questions via the Chat option. Aaron will be forum moderator and will field questions for appropriateness.

With only two candidates, the board discussed having enough meeting time for a second discussion topic, and suggested inviting Oceanside mayoral candidates. The consensus was to keep the meeting dedicated to the state rep candidates and host a separate meeting for Oceanside mayoral candidates (date to be determined after the election filing deadline on August 7).

Board members will continue discussing forum plans/logistics at the August 6 board meeting.
