Riane reported that 6 winners have been selected from the group of entries. <u>420 Remix Virtual Event</u>: PSA winners will be announced at the 420 Remix Virtual Event, April 20, 3-5PM; NCPC is collaborating with the SD County Office of Education/Friday Night Live Program to present San Diego Night's Game Show Program. The two-hour event will include a 45-minute prevention presentation with guest speakers and facilitated by youth coalition members. The prevention program will be followed by three rounds of video games, entertainment and cash prizes.

County CDC Opioid/fentanyl crisis – John Byrom:

NCPC is working with Oceanside Chamber of Commerce to present a NARCAN training to chamber staff members. Also reaching out to local retailers; 8 store managers have agreed to handout county Opioid Crisis flyers and/or display county posters in their stores.

Marijuana Policy - Erica Leary:

Kevin Sabet's new book, <u>Smokescreen (What the marijuana industry doesn't want you to know)</u>; extra copies available to loan out-if interested contact Erica.

Two competing bills on marijuana billboard marketing along California state highways are making their way through the legislature. Escondido City Council will discuss at the May 19th council meeting to either continue or lift ban on legal marijuana dispensaries. County BOS continues to discuss recommendations for allowing marijuana businesses to open in unincorporated areas of San Diego.

<u>Drug Take Back Day – John Byrom</u>:

DEA collected 7,850 pounds of unused/expired drugs at drop off sites around the county including Vista and Oceanside (TCMC). Thanks to Aaron and all the supporters who turned out to help with this event.

Coast News Article on NCPC - Aaron Byzak:

Aaron, Erica Leary and Rob Howard are working with Coast News to develop an article on NCPC, its history, present focus, and future goals and prevention efforts. The article will focus on the One Choice Initiative and highlight new members. The article should be published online in the next couple of weeks.
