IV. <u>Discussion Items:</u>

Board Membership:

Strategic Planning Presentation/Next Steps:

Board revisited plans to share Strategic Planning PPT presentation with membership at the September 9th GM meeting. Reviewed Erica's PPT and agreed it was a good idea to divide the presentation between board members. Aaron suggested 2-3 presenters to touch on relevant key points, keeping it interesting and simple. He recommended one past member to present on history/foundation/SWOT data, and suggested new members (Jose, Kristal, Rob) to present on NCPC's future: where do we want to go? Goal is to gather input from the GM on listening session questions and put out a simple call to action, "Who do we need to talk to that isn't already on our list of potential partners and collaborators? It was agreed that the PPT needed to be simplified, less text, and possibly provided in document form prior to the meeting. V. **Program/Policy Updates:**

NCPC video creation – Call to Action Update: Aaron Byzak.

Group decision to share the existing video with already established NCPC youth groups, ask 2-3 simple questions for input on video content and call to action message. Example: Does this video communicate to you NCPC's message; how would you amend the video to achieve/spread NCPC's message? Erica suggested creating a Survey Monkey with link to the video.

Fentanyl/Opioid Crisis Outreach Efforts:

Erica Leary reported that the County CDC Opioid Crisis funding will be used to cover two projects: printing and mailing 30K postcards (double-sided English/Spanish) to residents living in priority zip codes in Oceanside and Vista; publishing the postcard in two editions of the Coast News and also in the Oceanside Chamber Magazine.

John reported he is collaborating with the Vista District Attorney's office, Vista Sheriff's Dept. and Vista School District on an event being organized in Vista to raise awareness in the Hispanic community about reporting crime. The event is planned for Saturday, November 6, 1-3PM at the Vista Civic Center Community Room.
