Kickoff and Tip off Sports with Prevention: David Escovedo provided an overview of North Inland Region's effort to deliver substance use prevention messaging in all school sports. The overall philosophy of this effort is to change social norms and conversation about alcohol and drugs during high school sporting events that will ultimately reduce underage youth access to drugs and alcohol. The program puts substance use prevention messaging on everyone's scorecard at sporting events year round, reaching students, parents, teachers, factuality, administrators, districts, and the community at large.

Following the presentation, NCPC members discussed the program and exchanged ideas on how to move toward and promote the policy of including multiple alcohol and drug prevention messages in all sporting events. The group consensus was very positive and supportive — everyone approved collaboration and support for future efforts. MHS added that they can provide red ribbons and stickers if needed.
