- IV. **Presentation: Rose Pellegrini, Safe Families for Children (SFFC).**

Rose Pellegrini, San Diego Intake Coordinator for **Safe Families for Children (SFFC)**, shared a PPT overview of the SFFC program. SFFC is a collaborative effort with Olive Crest (Safe Families/Strong Kids) and other non-profit agencies and social service providers working together to offer temporary homes for children under age 18 whose families are in crisis and would benefit from their children being cared for by an approved host family for a short period of time. Program goals are early intervention, child abuse prevention, and family support. Referrals come from relatives, friends, social service agencies, drug and alcohol treatment facilities, schools, churches and law enforcement. Also included in the PPT are pre and post pandemic program data points.
