
# RBV Public Policy Club – A Year in Review


# **2021-2022 Highlights**

# What Do People Think About Smoking/Vaping on Outdoor Dining Patios in Vista\*



93% prefer an area where smoking/vaping is NOT allowed when eating outside

85% have been bothered by smoking or vaping when eating outside

80% eat at restaurants in Vista once a month or more

50% would eat out MORE if outdoor dining areas did not allow smoking or vaping



92% believe Vista should join other north county cities that prohibit smoking/vaping on outdoor dining patios.
