Carina shared a photo slide/montage which highlighted some of the events that the STAY Club participated in this past school year. These events and activities allowed youth members to share resources with their community on the dangers of second hand smoke, benefits of having smoke free environments, and asking community leaders to strengthen Vista's Tobacco Retail Licensing policy.
