IV. Guest Presenter: Melissa Ryan, ABC

Melissa Ryan from the Department of Alcoholic Beverage Control (ABC) gave an overview of recent changes in ABC structure and programs. She now has the role of Supervising Agent in Charge for SD County focusing on enforcement. ABC has launched a Community Partnership Program to focus in underserved communities to partner with

residents, local law enforcement and ABC to take a non-disciplinary approach to improve licensees. She has worked the program in Spring Valley and Escondido (special shout-out to Patrick Holstrom and Pearl Cerda with Drug Free Escondido for their partnership). She also gave updates on new State laws and stated that ABC Director Hirata's priority is to reduce youth access to alcohol and improve problematic licensees. They plan to conduct at least one decoy operation and 15 impact inspections per month.
