Marijuana Prevention Forum:

NCPC co-sponsored a Marijuana Prevention Forum with VUSD at Madison Middle School on October 20. The guest speaker was Joe Eberstein, Program Manager with the County's Marijuana Prevention Initiative. 150 students and 20 parents attended. Media clip from Channel 8, including interviews with attending students, was shared.

Annual Sticker Shock Campaign:

Annual Sticker Shock Campaign is set for Monday, November 21, with campaign kick-off starting at 10 AM at the Chevron Gas Station, 3490 Marron Road and College Blvd. The campaign goal is to educate and increase community awareness regarding Social Host Ordinances and the consequences of underage access to alcohol at house parties. Youth coalition members and adult leaders will visit a dozen local retailers to place informational stickers on multi-pack beer containers.

Underage Drinking Forum:

NCPC will host an Underage Drinking Prevention Forum on Tuesday, December 6 from 6 to 8 PM at El Camino High School's Truax Theater. STOP Grant:

VCC/NCPC has been awarded a STOP Act Grant (Sober Truth on Preventing Underage Drinking). The grant start date was September 30. The focus of the four-year grant program is primarily young adults in Oceanside (ages 18-25) as alcohol suppliers to younger teens (ages 13-17) A new Prevention Specialist, Lauren Pallasigui, and Data Specialist/Evaluator, Jessica Wombolt, have been hired to work on the grant.
