### I. Welcome and Introductions: Craig Balben, President.

The meeting was brought to order at 8:15 AM.

### **II.** Approval of Meeting Minutes: March 9, 2017:

They provided a recap of some of their activities including Sticker Shock Campaign, Underage Drinking Forum, attending local city council meetings, participation at the annual FNL/YDI (Youth Development Institute) Camp, and an exciting trip to Sacramento to attend Youth Quest and speak with local legislators (flight back was delayed and diverted overnight to Phoenix). NCPC thanked the teens for taking time during spring break to attend the meeting and congratulated them on their work in support of NCPC's mission and prevention goals. Angel Jaramillo, one of the presenting teens, was awarded the first place prize for his 420 PSA contest entry, "Marijuana Man." Outstanding job Angel – Congratulations!

Marijuana Dispensary Workshop Oceanside/Medical Marijuana Dispensary Bans in Vista & Carlsbad – Erica Leary: Oceanside City Council held a public workshop on April 4 to address how the city will deal with Prop 64 and the ban on pot dispensaries. At the workshop, Councilmember Lowery suggested a resolution to form an ad-hoc committee to look further at regulating medical marijuana in Oceanside (cultivation, dispensaries, delivery). The council will be considering the resolution at their April 19 council meeting.

Vista City Council members will address the city's medical marijuana ban at their meeting on April 25, and the city of Carlsbad will also consider an ordinance to change the city's municipal code to ban commercial marijuana activity and regulate cultivation at their meeting on April 25.
